Dear Sir,

As you may be aware the Ministry of Statistics and Programme Implementation has been entrusted the responsibility of overall monitoring of various programmes covered under the Twenty Point Programme-2006. In this context I would like to draw your kind attention that certain organisations using variations of the name like Krishi Bikash Shilpa Kendra, Krishi Vikas Shilpa Kendra, Krishi Bikash Silpa Kendra etc. are trying to cheat the public by claiming to be organizations of the Government of India. They claim they are engaged in implementation of the Twenty Point Programme-2006 on behalf of the Government of India. These organisations are also fraudulently issuing appointment letters and identity cards bearing the emblem of Government, of India to the public.


2. Copies of various documents issued by these organizations which bears the National Emblem, the phrase "New 20 Points Programme Implementation", "Government of India" and the Order purportedly issued by Late Prime Minister Smt. Indira Gandhi alongwith her photograph, name of Ministry of Agriculture, are enclosed. Copies of the appointment letters and Identity Cards issued by them are also enclosed.

3. You may be aware that various programmes/schemes of the Government of India covered under Twenty Point Programme are administered by the Nodal Ministries concerned and implemented by the State Governments/Union Territory Administrations. This Ministry has not at any stage authorized any organisation to implement the Twenty Point Programme or any part of it, on behalf of this Ministry nor have we provided any financial assistance in this regard.

4. Keeping in view the gravity of the matter, if any such organisation or their representatives in your state come to your kind notice, please get it investigated and take appropriate action as per law. I shall be grateful, if you could kindly inform all district officials accordingly and keep this Ministry informed about the existence of any of such organisation in your state and necessary action initiated by the state in this regard. For your kind information a copy of a news item that appeared in Bardhaman.com for 21<sup>st</sup> April, 2004 is also enclosed. As such organizations are defrauding the public, urgent action is requested.

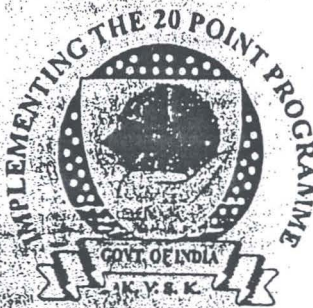

### KBSK OFFICIALS ARRESTED IN MADHABDIHI

**Burdwan , 21 Apr. 04 :**

Five officials of the controversial NGO Krishi Bikash Silpa Kendra (KBSK) were arrested by the Madhabdihi police. **The organisation's activity was first brought to the notice of the district police & administration by bardhaman.com on 17.03.04.** The organisation was reported to demand money from job seekers at the organisation. They also dared to use the **national emblem** illegally to establish itself as a 'central government undertaking' in the eyes of the job seekers. The organisation again came into limelight when they printed the name of the DM & SP of Burdwan without their consent, at a blood donation camp arranged by them on 05.04.04.

Police sources revealed, the organisation opened its office at the Lohai bazaar area. The signboard of the organisation carried the national emblem. Kamal Sahana, a local youth lodged a complaint on Monday against the organisation that, it demanded Rs. 50,000 in lieu of a job at the organisation. "I believed them primarily & paid an advance of Rs. 2,000 on

12.04.04. I was informed that appointment letter will be issued after seven days. On the day when I asked for the appointment letter, I was told the same can be received by me if I can arrange for 10 more job seekers like me. I was promised my remaining due of Rs. 48,000 will be waived off in such case. This made me suspicious about their intention & activities" said Sahana.

The police on arrival at the organisation didn't find any valid documents which permits them to use national emblem & 'Govt. of India' declaration. The officials even failed to produce documents to support their identity as a NGO also. Police arrested Sk. Jamat Ali, the self declared director, his wife Sakila Begum & three more employees of the organisation, Kashinath Samanta, Madhusudan Sahana & Parimal Nayek. They were produced at the Burdwan court. Jamat Ali was sent to the police custody & the rest to the jail.

Sources revealed that, this office was opened & maintained by a group of the organisation operating from nearby Arambag in the Hooghly district. Quite coincidentally, the former secretary of the KBSK, Shaktipada Bagdi is reported to be imprisoned at the Arambag Sub-divisional Jail. None of the organisation's heads were available to comment on the incident.

This incident again proved that the organisation has penetrated deep into the adjoining districts namely, Hooghly, Bankura & Birbhum as reported by **bardhaman.com** earlier.
