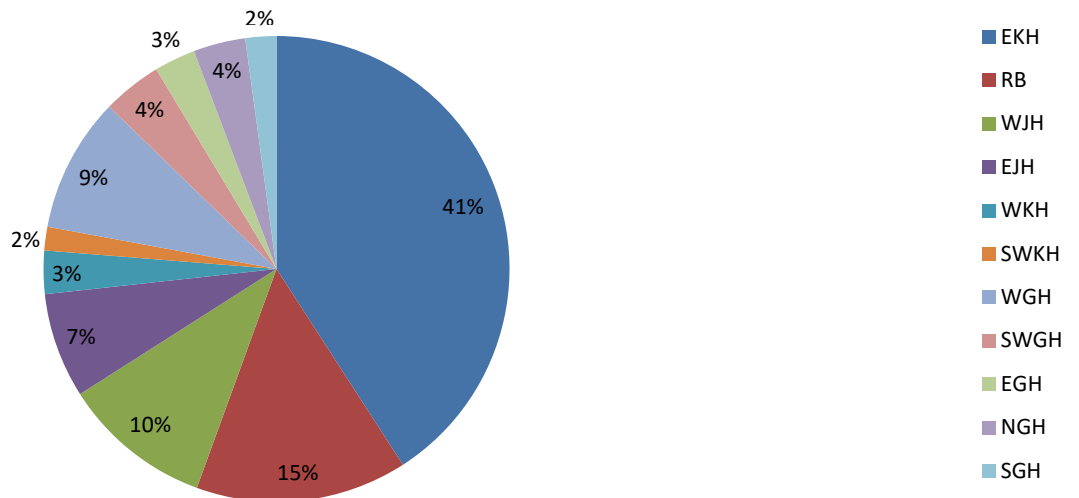

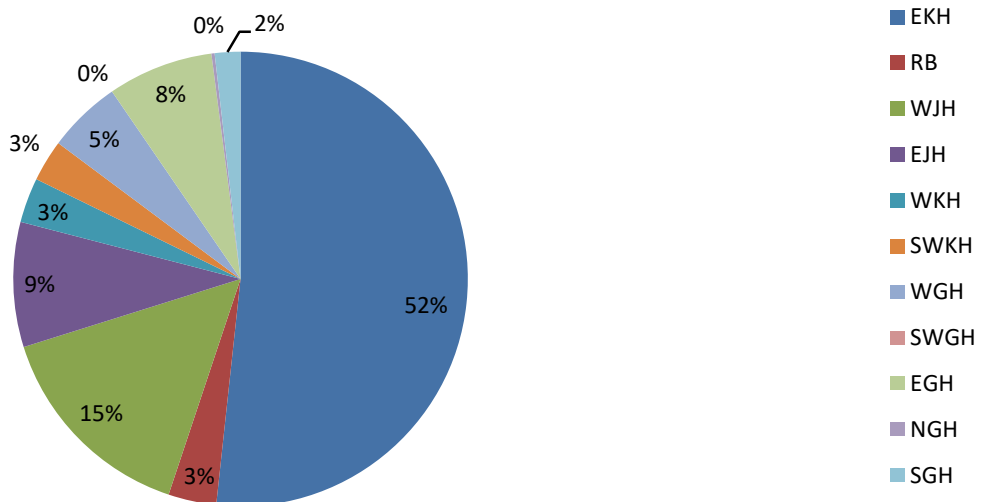
TOTAL COGNIZABLE CRIME REPORTED UNDER IPC

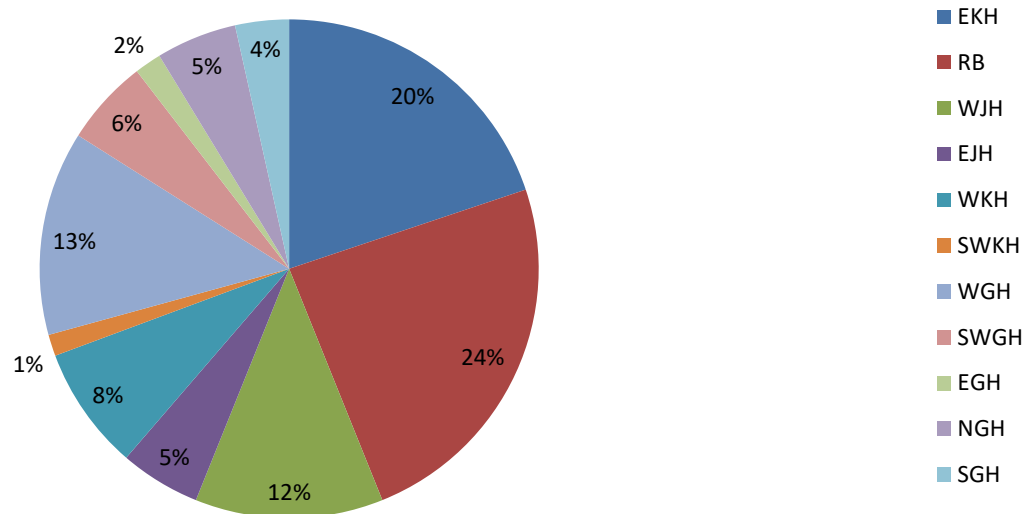
TOTAL COGNIZABLE CRIME REPORTED UNDER LOCAL & SPECIAL LAW
